



marriage on 27-01-2015 and thereafter ^{on} acceptance of the
registry marriage by the ^vparents and other members of the
family of the complainant social marriage was performed
between the complainant ^vand Julie Adhia on 17-2-2016. As
the marriage was the consequence of love affair ⁱⁿ that

that there was no presentation or gift from the side of Julie Adhia and her mother but as a mark of respect the old grand father of the complainant out of some old ornaments of his wife few golden ornaments were presented to Julie Adhia by Kamalakanta Das Karmpkar, ~~an~~ grand father of the complainant. After the marriage some time they were leaving without any much trouble. Accused Susila Adhia who was a widow of not so much age frequently instigated the complainant to remain as Domesticated husband (Gharjemi) in her house but the complainant did not agree with the proposal of Susila Adhia., the complainant is the only son of his parents and he has his ^{only} sister suffering from unsoundness of mind., the complainant is an unemployed person though he sit in the small shop of his father and grand father and helps them to some extend. Susila Adhia being ^{the} unsuccessful in persuing her expectation of having the complainant as Gharjemi started to torture the complainant on demanding heavy money from him to bring from his grand -father. Gradually Julie Adhia and her mother - Susila Adhia with conspiracy of accused Tarapada Das used to torture the complainant by abusing him and insulting him every day.





and even threaten the complainant that unless the complainant persuade his grand father to make gift his all properties in the name of Julie Adhia then the complainant will be killed, and he was not allowed to enter even the house of Suslia Adhia, when Julie Adhia used to remain with her. It is mentioned that by this time a female child was born to Julie Adhia and all the expenditure in respect of the born of the child was met by the complainant..

That thereafter Julie Adhia and her mother Susila Adhia sometime confined in their another room the complainant without any food and he was not allow to go to his father house. It is mentioned that the father house of the complainant and his matrimonial house are situated not in far place., for which Julie Adhia without any knowledge and permission of the complainant and his other family members used to go to her mother's house and on each occassion the complainant had to go to bring her but Julie Adhia refused to come back to her matrimonial house ^{some time,}

On the day of occurrence the complainant had been to his matrimonial home in the noon with expectation that he will spent there for two three hours and

will bring ^{Julie} ~~Susila~~ Adhia to his house and he wanted some "Juwan" when Julie Adhia being instigated by Susila Adhia, Tarapada Das and the another man Julie Adhia wanted Rupees one crore from the complainant ^{and} when the complainant expressed his inability to pay the huge amount of money to her then all the four persons started to assault ^{ed} him by fist and blows and Julie Adhia and her mother Susila Adhia by a wooden log pressed the neck of the complainant trying to murder him and the complainant some how saved himself but he got injury on the front side of throat ^{and} other places, the ~~native~~ voice ^{was} of the complainant choked and he could not speak and was groaning in pain and ^{there} ~~was~~ breathing trouble and all the accused persons cried that "kill him" but the complainant to save his life some how went to his house and with his father went to Purulia Sadar Hospital, ~~where~~ and the doctor there on duty immediately admitted him in the hospital in M.S.I.-II and the treatment was started. Thereafter father of the complainant ~~Prabir Das Karmakar~~ filed a written complainant in the Purulia Town P.S. for the incident. The

There are witnesses to the occurrence neither the Police of Purulia Town P.S. nor the Superintendent of Police, Purulia took any action against the culprits, ^{till now} the complainant has been compelled to file this complaint before your Honour the case is a serious one and unless a police case is started ^{regarding} ~~evading~~ the incident the complainant will not be able to conduct this case on his means.

Under the circumstances it is prayed that your Honour may kindly be pleased to admit the complaint and be sent to the officer in charge of Purulia town police station under section 156(3) Cr.P.C. to treat this as F.I.R. and to investigate and report.
