N Vill- Kalipur, PO- Simulia, PS-Purulia (M), Dist-Purulia, Pin-723102 for IFB Agro Industries Limited @ of printed Rs. 35/-(Thirty Five) each in per bottle which is amount total Rs. 1400/- (One thousand four hundred) only under proper seizure list and being labeled properly, I beg to report that today in course of special mobile duty at 19:45 hrs. received a telephonic information from source that one person namely Sanjoy Bauri @ Chattu (27 yrs) s/o- Lt. Tapan Bauri of Ketka, Sayer Para, Ward No- 09, PS Purulia (T), Dist Purulia was selling country spirit at Ketka near Water Tank of Railway. Accordingly I informed to O/C the matter and thereafter obtaining permission from O/C Purulia (T) PS, I ASI Ajoy Mukhopadhyay, NVF/797 Badal Singh Mura, HG/1454 Prakash Char left for working out the information. We reached Ketka near Water Tank of Railway and keeping the vehicle at a reasonable distance we proceeded to the place of information as being shown by the source from distance. We entered in the place and found one person namely Sanjoy Bauri @ Chattu was selling country spirit and some persons were drinking in the courtyard of that place. Seeing the police all persons fled away leaving some plastic glasses but he could not flee away. We apprehended him and on searching we recover 40 (forty) bottles of 'Dil Se'. On being interrogated the youth revealed his identity as Sanjoy Bauri @ Chattu (27 yrs) s/o- Lt. Tapan Bauri of Ketka, Sayer Para, Ward No-09, PS Purulia (T), Dist Purulia. On asked he could not produce any license in favour of selling, keeping or possessing country spirit. Accordingly I seized 40 (forty) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 600ml of country spirit having strength 80° UP being sealed properly) Manufactured Blended and bottled by Singh Fisher from his possession after labeling and sealed properly and took sample and arrested him observing all the formalities regarding arrest as his offence comes under the ambit of 46A of B.E. Act 1909.

Hence a specific case may kindly be started and arrange for its investigation.
