your Complainant and committed theft of one Lap-Top of the son of your Complainant, who has been <sup>prosecuting</sup> ~~proceeding~~ his studies.

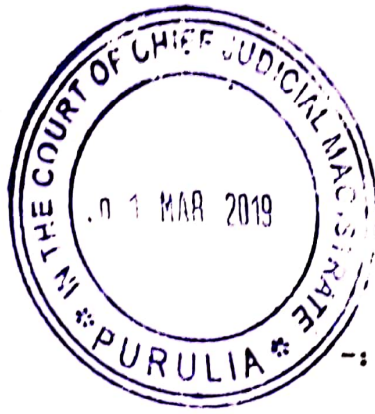
