Sir,

In producing herewith the arrested accused person namely Iswar Dhibar (21 yrs) s/o Archan Dhibar of Biltora, PS- Raghunathpur, Dist- Purulia along with seized one black colour pistol with 01 Pc. of Magazine loaded with 4 Pcs. 7.65mm live ammunition to the fact that on 11.03.19 while I, SI Prabir Kr Banerjee along with C/646 Purna Chakraborty and C/985 Laxman Ch. Majhi were engaged in Naka mobile duty on Purulia – Barakar Road under Raghunathpur PS vide Raghunathpur PS GDE No 422 dt 11.03.19 & C.C. No. 669 dt 11.03.19 at 14:05 hrs, received credible source information that two persons being equipped with fire arms, coming from Iharukhamar side towards Raghunathpur side by a motorcycle.

Accordingly I informed the matter to I/C Raghunathpur PS and as per his direction I along with force left to work out the information and reached at Kelahi Jangle and placed Naka checking with my accompanying force. On way I briefed my accompanied force about the above noted matter and at about 14:30 hrs found two persons was coming from Jharukhamar side towards Raghunathpur side. We try to stop the said motorcycle but the rider of motorcycle fled away with his motorcycle without number plate but we managed to apprehend the above noted person.

On being asked the person disclosed his name and address as Iswar Dhibar (21 yrs) s/o Archan Dhibar of Biltora, PS- Raghunathpur, Dist- Purulia. On being searched of him one black colour pistol along with 01 Pc. of Magazine loaded with 4 Pcs. 7.65mm live ammunition could be recovered from the possession of the above noted accused person which was kept the right side of his waist under his full pant. On demand he failed to produce any valid document in respect of possession of arms and ammunition. He also confessed that he had procured the same to commit any crime at Raghunathpur Town area with his associates. Hence, I arrested him issuing arrest memo, informed ground of arrest and other guidelines regarding arrest. Then, I seized one black colour pistol along with 01 Pc. of Magazine loaded with 4 Pcs. 7.65mm live ammunition under proper seizure list and proper leveling duly signed by the above noted accused person and police witnesses. No public witnesses are available at that time at Kelahi Jangle area.

On return to PS, I lodge a complaint against Iswar Dhibar (21 yrs) s/o Archan Dhibar of Biltora, PS- Raghunathpur, Dist- Purulia and one unknown other person with a prayer to start a specific case as per law and arrange for its investigation.
