Sir,

With due respect and humble submission, I beg to submit that I ASI Biswarup Roy alongwith C/1154 Jagannath Jha & C/1052 Shyamlal Murmu all of Santuri P.S. while performing night mobile duty on 01.03.19 at 04:35 hrs. received a credible source information that a truck bearing registration No.JH10BQ-4136 loaded with coal which has been procured by means of theft or any fraudulent manner is proceeding towards Santuri side from Raghunathpur side through Raghunathpur – Saltora road (SH-8). After receiving the said information we have started NAKA checking duty at Rambhattadih with a view to intercept the said vehicle. At about 05:25 hrs. we found the aforesaid vehicle is coming from Raghunathpur side and Seeing police party at Rambhattadih more the driver of the said vehicle flee away by stopping the vehicle on road. We have tried to apprehend the driver but failed. On reaching near said truck I alongwith my accompanying force searched the vehicle and found that the Truck was carrying 18 MT(approx.) coal. No such document could be found in respect of said Truck. It is reasonable to believe that the owner of said vehicle (JH10BQ-4136), driver of the truck(JH10BQ-4136) and others collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and habitual to run this business. So, I have seized the said Truck(JH10BQ-4136)under proper seizure list. I have also sealed & labeled approx.01(one) K.G coal as sample from the major contraband. There was no such public witness available at the time of seizure. Thereafter arranging a public driver I brought the seized Truck loaded with coal at Santuri P.S compound.

I therefore pray before you to lodge a specific case against the owner of the Truck (JH10BQ-4136), driver of the vehicle and others under proper section of law.
