In producing here with one arrested accused namely Bivash Banerjee (52 Yrs.) S/O Lt. Sasadhar Banerjee of Kamlasthan PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 18 bottles (in sealed condition) DIL SE 80 up country spirit, 600-ml each bottle and value-Rs-35 of each
- 2) 07 pieces of plastic glass.

I ASI Tapas Kr. Panda Adra Police Station do here by lodged a complaint against accused persons namely Bivash Banerjee (52 Yrs.) S/O Lt. Sasadhar Banerjee of Kamlasthan PS- Adra Dist- Purulia & Partha Banerjee S/O Lotan Banerjee of Kamlasthan PS- Adra Dist- Purulia to the effect that on 15.03.19 at about 17:35 hrs. in course of my evening mobile duty I received a telephonic information from a reliable source that Bivash Banerjee (52 Yrs.) S/O Lt. Sasadhar Banerjee of Kamlasthan PS- Adra Dist- Purulia & Partha Banerjee S/O Lotan Banerjee of Kamlasthan PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for their personal gain then I intormed O/C Adra PS and as per order of O/C Adra PS myself along with C/122 Rabindranath Verma & C/230 Ashis Mahadani rushed to the spot for raid by Govt. vehicle. At about 17:45 hrs. myself along with force reached at Kamlasthan More and hold raid in the Jhupri of Partha Banerjee found that said Bivash Banerjee & Partha Banerjee stocked liquor at his own Jhupri and selling the same to the consumers. Seeing the Police party some persons including Partha Banerjee & Bivash Banerjee tried to flew away but however after a small chase we were able to apprehend Bivash Banerjee but Partha Banerjee fled away. I asked Bivash Banerjee to produced valid License or valid papers of selling liquor but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested Bivash Banerjee (52 Yrs.) S/O Lt. Sasadhar Banerjee of Kamlasthan PS- Adra Dist- Purulia & Partha Banerjee S/O Lotan Banerjee of Kamlasthan PS- Adra Dist- Purulia and arrange for its investigation.
