In producing here with one arrested accd namely Rahin Soren (39) S/O Pelaram Soren of vill Herodih P.S.-Arsha Dist-Purulia along with following seized articles viz -

1) one white colour plastic container with approx 10 ltrs of cholai, 2) one white colour plastic container with approx 5 ltrs of cholai,. (Approx 500 ml taken out from the above containers as sample packed with sealing wax) 3)10 nos of used plastic glass in one plastic bag

I ,ASI Pradip Bhattacharjee of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today 15.03.19 at about 18:40 hrs during my evening mobile duty received source information over telephone that the above noted accused has been selling liquor illegally and clandestinely in front of his house at Herodih village under Arsha PS, Dist-Purulia. I therefore pray that a specific case may kindly be started against the accused namely Rahin Soren (39) S/O Pelaram Soren of vill Herodih P.S.-Arsha Dist-Purulia U/S 46A(c) The Bengal Excise Act, 1909, and arrange it's regular investigation.
