Sub: Report of physical torture and assault by husband

Sir,

I Jaba Singh Sardar nee Mura w/o Sri Sanajit Singh Sardar & d/o Nibaran Chandra Mura R/o Vill- Hakasarah, P.O- Khatanga, P.S- Kotshila, Dt- Purulia, do inform you that I married one Sanajit Singh Sardar s/o Late Purandar Singh Sardar on 12/09/2017 by way of a both sided love affairs. The said marriage was duly registered as per provisions of Special Marriage Act before Sri Rajendra Prasad Upadhyay, Ex- Officio Special Marriage Officer for Purulia Sadar on the same day. My parents came to know about after completion of registration of the same.

After the marriage, I was taken to the residence of my husband situated at Vill- Matha, P.O- Matha Forest Range Office, P.S- Bagmundi, Dt- Purulia.

At the time of marriage I was a spinster graduate (Bengali Hons.) lady and my aforesaid husband was then a Master Degree holder (M.A, B.ED) Bachelor.

My marriage with aforesaid Sanajit Sing Sardar is a result of a mutual love affair which was started at the end of the year 2016 though I know him for a long period i.e. at the time of the marriage ceremony of my elder sister Smt. Padmabati Singh Sardar. It is pertinent to mention here that Sanajit Singh Sardar is the younger brother of the husband of my elder sister Smt. Padmabati Singh Sardar i.e. Sanajit Singh Sardar is the Debar of Smt. Padmabati Singh Sardar. As such I and my elder sister Smt. Padmabati Singh Sardar are two house wife of the same family.

My husband Sanajit Singh Sardar is a private tutor by profession having on an average 250 students of the locality. Moreover he his holder of landed property and a business of rending out tractors and hand tillers.

Initially only a few days passed by happily but all on sudden my mother-in-law Smt. Jaleswari Singh Sardar and my sister-in-law Smt. Balika Singh Sardar and her husband Sri Jagadish Singh Sardar, my brother-in-law Sri Mahendra Singh Sardar and Sri Uttam Kumar Singh Sardar, another sister-in-law Smt. Sulekha Singh Sardar and my husband Sri Sanajit Singh Sardar started torturing me physically and use filthy languages to create mental pressure upon

me to bring Dowry from my father Sri Nibaran Chandra Mura in form of cash money, jewelries, new private car and branded apparels..

In retaliation my mother-in-law started throwing false allegation upon me on various issues. Many a times whenever my husband return to home my mother -in-law use to start complaining that I misbehaved with her and refuse to perform household jobs as per advice of my mother-in-law in turn naturally upon here in such compliance my husband a hot minded man use to assault me with fist, blows, and kicks.

After few days all on a sudden due to nonpayment of Dowry by my father, my in laws drove me and my husband out of my matrimonial home alleging that I am not at all a member of the family of my husband.

Then my husband and I shifted to a village namely Bhadudihi, P.S- Chandil, Jharkhand. Where in my husband forced me to work as a labour to take carry stones from one place to another in crusher plant in spite of knowing the fact that I am a graduate lady. Surprisingly my husband use to sit back and enjoy my income. At that place my husband assaulted me physically several times upon trivial household issues. I realized that I have been caught in a trap placed by my husband and I am only a money earning tool for my husband, actually my husband wants to get rid of me by way of torturing me and thus killing me in disguise of illness. Because I felt seriously ill due to this type of inhumanic torture and giving any type of medical assistance, my husband dropped me back to my paternal home. My husband stopped keeping contact with me and his phone number was found to be switched off.

Getting nowhere about my husband, I was compelled to approached the Panchayet with my problem. The Panchayet called both the families i.e. me and my husband and fixed up 22/04/2018 as the dated of my social marriage. There after I again move to my matrimonial home to live a marital life but my in-laws drove me out and did not allow me enter my matrimonial home and show me a Notarized Deed of Declaration by which she i.e. my mother - in - law declared her younger son i.e. my husband as Disadvantage (Tyajjo Putro) and so I had no right at all enter into the house.

On 11 05 2018 I informed the whole matter to the Baghmundi P.S wherein the authority of the said Police Station ensured appearance of my husband and my husband promised in writing that he would make necessary arrangements so that I can lead a married life with my husband. But just after coming out from the police station my husband accompanied me to my paternal home and demanded Rupees 10,00,000/- ( Ten lac ) only and thereafter he kept no contact with me.

This is for favour of kind disposal & taking necessary action against my husband.
