> Sub: Lodging F.I.R against Khalif Momin, S/o. Surmali Momin for unauthorized use of Electricity by way of hooking u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, D.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Khalif Momin, S/o. Surmali Momin resides at Vill–Bara Urma, PO-Bara Urma, PS: Balarampur, Dist. Purulia to the effect that received an information, that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the nearby LTOH Line of WBSEDCL to bypass the proper registration of units in the energy meter of WBSEDCL.

Acting upon such information on 10.04.2019 from 2.05 PM to 2.40 PM I, along with Sri Manab Kr. Maji, S.A.E, Sri Arindam Chatterjee, O.E Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Khalif Momin and held raid.

During raid and inspection it was detected that accused Khalif Momin is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1 Nos 100 Watts Lamp, 1 No. Table Fan, 2 Nos. 9 Watts LED Lamp and 1 No 60 Watts Lamp having connected load 0.238 KW. There exists one Service Connection of WBSEDCL bearing Consumer D: 200295060 stands recorded in the name of the accused which has been disconnected on detection of theft of electricity.

I prepared Inspection report in presence of the Accused and assessed the Load as 0.238 Kw. Details have been mentioned in the Inspection Report duly signed by the accused.

I directed Sri Rajib Sahis, Supervisor of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line/ arrangement from our LTOH line. Accordingly they disconnected the aforesaid hooking line/arrangement from LTOH Line.

I prepared seizure list in presence of the accused & witnesses, details of seizure have been mentioned in the seizure list and obtained signature of the accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue. It is well evident that the abovementioned accused person has committed offence u/s 135(i)(a) and 135(i)(c) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused. Encl:
