Respected Sir,

In producing here with one arrested accused person namely Lakhan Gorai (50 yrs) S/O- Lt. Dhananjoy Gorai of Vill.- Bhikari Cheliama, P.S.- Barabazar, Dist. Purulia along with seized 12 (twelve) sealed country sprit bottles (DIL SE) (Each Bottle 600 ML X 12 bottle=7.2 liters) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs. I received a credible source information that one Hotel owner of Lakhan Gorai S/O- Lt. Dhananjoy Gorai of Vill.- Bhikari Cheliama, P.S.- Barabazar, Dist. Purulia is selling country sprit without any valid license from his own Hotel at Pratima Hotel near Berma Check Post under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Pratima Hotel near Berma Check Post to work out the source information. Thereafter we reached at Pratima Hotel near Berma Check Post at about 19:25 hrs and held raid in the Hotel of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his Hotel. On demand, he failed to produce any valid documents & valid License in respect of selling and keeping of said country sprit but he failed produced the any valid documents. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 12 (twelve) sealed country sprit bottles (DIL SE) (Each Bottle 600 ML X 12 bottle=7.2 liters) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Lakhan Gorai S/O- Lt. Dhananjoy Gorai of Vill.- Bhikari Cheliama, P.S.-Barabazar, Dist. Purulia and arrange for its investigation.
