In producing here with one arrested accused person namely Arjun Saw (48 yrs) S/O- Lt. Chuman Saw of Balarampur Tata Road, P.S.- Balarampur, Dist. Purulia along with seized 11 (eleven) sealed country sprit bottles (DIL SE) (Each Bottle 600 ML X 11 bottle=6.6 liters) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:25 hrs. I received a credible source information that one Hotel owner of Arjun Saw (48 yrs) S/O- Lt. Chuman Saw of Balarampur Tata Road, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own Hotel at Suravi Hotel, Balarampur Tata Road under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Suravi Hotel, Balarampur Tata Road to work out the source information. Thereafter we reached at Suravi Hotel, Balarampur Tata Road at about 19:05 hrs and held raid in the Hotel of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his Hotel. On demand, he failed to produce any valid documents & valid License in respect of selling and keeping of said country sprit but he failed produced the any valid documents. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 11 (eleven) sealed country sprit bottles (DIL SE) (Each Bottle 600 ML X 11 bottle=6.6 liters) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Arjun Saw (48 yrs) S/O- Lt. Chuman Saw of Balarampur Tata Road, P.S.-Balarampur, Dist. Purulia and arrange for its investigation.
