Sub: Prayer for starting a specific case against (1) Sunil Mandi (35 Yrs) S/o- Lt. Madan Mandi of Village Salghati, PS- Barabazar, Dist- Purulia (2) Darga Soren (35 Yrs) S/o- Gobardhan Soren Village- Punrru, PS- Kenda, Dist- Purulia.

Sir,

In producing herewith the arrested accused persons against (1) Sunil Mandi (35 Yrs) S/o- Lt. Madan Mandi of Village- Salghati, PS- Barabazar, Dist- Purulia (2) Darga Soren (35 Yrs) S/o- Gobardhan Soren Village- Punrru, PS- Kenda, Dist- Purulia along with seized 26 Containers of Fermented wash each containers contain 20 Liters (Seized & Destroyed), one Aluminum made big Handi, 155 liters of finished I.D liquor I beg to submit that on 11.03.2019 at 16.45 hrs I got a source information that two persons were preparing I.D liquor at Village Salghati and the source will help identify the place. Accordingly I inform the matter to I.C Barabazar PS and as per his direction diarized the matter vide GDE No- 495 Dtd. 11.03.2019.

Accordingly, myself along force C/- 357 Gopal Biswas & C/- 346 Shaktipada Rajak left for Salghati village, PS Barabazar with govt. vehicle having No- WB 26K 2675 vide GDE No- 496 Dtd. 11.03.2019. At around 18.05 hrs reached at near Salghati Village and parked the vehicle at a considerable distance and by foot reached the house of Sunil Mandi as shown by source. At around 18.25 hrs source as indicated by source we reached at the courtyard of house of said Sunil Mandi. We found that he was operating one I.D liquor manufacturing at his house. We found another person at that courtyard who was assisting Sunil Mandi for smooth operation of their I.D liquor manufacturing unit.

I disclosed my identity to them & requested their identity. After a little pause they disclosed their identity as noted above. I inform them the cause of detention and requested them if they want they can search us. But they declined. I search the place and found 26 Containers of Fermented wash each container contains 20 Liters, one Aluminum made big Handi, 155 liters of finished I.D liquor. It was detected that the liquid is I.D liquor and the other liquids are fermented wash (Basic ingredients of I.D liquor) and other equipments of manufacturing of I.D liquor.

Accordingly, I seized the 26 Containers of Fermented wash each container contain 20 Liters, one Aluminum made big Handi, 155 liters of finished I.D liquor under proper seizure list and marked the I.D liquor as Exhibit- A; from the total materials I kept approx 01 liter as sample and mark as Exhibit- A1. After proper seizure I destroyed the fermented wash. The seizure list was prepared at P.O (23.172144, 86.385735- Location) and duly signed by detained persons and witnesses. I sealed and labeled the bottle. As they failed to produce any documents, I arrested them at 19.25 hrs by issuing memo of arrest. Then myself alongwith force, seized articles, all relevant papers and accused persons left for PS.

On arrival at PS around 20.15 hrs I reached at PS and prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer at 20.45 hrs for starting a case under proper section of law against the accused persons (1) Sunil Mandi (35 Yrs) S/o- Lt. Madan Mandi of Village- Salghati, PS- Barabazar, Dist- Purulia (2) Darga Soren (35 Yrs) S/o- Gobardhan Soren Village- Punrru, PS- Kenda, Dist- Purulia for illegal manufacturing, selling of intoxicant.
