Subject: Complaint against Girijal Murmu (50 Yrs), S/O- Late Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. person Girijal Murmu (50 Yrs), S/O- Late Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia with seizure of approx 40 liters illicit spirit, containing in 02 (Two) twenty liters Red coloured Zariken from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (14.04.19) during my evening mobile duty inbetween 16:35 hrs to 17:05 hrs on acting secret source information I apprehended the above noted person at Ukamgarh at his house and found that above noted ID Liquor which was kept in his house. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents / License in r/o said illicit spirit which were kept in his house containing approx 40 ltrs illicit spirit, in 02 (Two) twenty liters Red coloured Zariken. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 17:05 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 1000 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Girijal Murmu (50 Yrs), S/O- Late Mahananda Murmu of Vill-Ukamgarh, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/662 Dhananjoy Pandey, (2) C/ 358 Ganesh Chandra Roy accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Girijal Murmu (50 Yrs), S/O- Late Mahananda Murmu of Vill- Ukamgarh, PS - Boro, Dist - Purulia.
