Sir,

In producing herewith the seized articles i.e. (1) One improvised full iron made fire arms (Country made) having butt body barrel, trigger, firing pin etc, total length approx 10 inches, barrel approx 5.5 inches and butt approx 03 inches (2) One 8 mm live cartridge (Ammunition) under proper seizure list, and lodged this complaint against the accd namely Bubai Hazra (32 yrs) S/O Sadhan Hazra of Kahipur Upar Para P.S Kashipur Dist Purulia to the effect that today i.e. on 16.04.19 I interrogated PC accd Bubai Hazra in C/W Kashipur P.S Case No 20/19 Dt 16.04.19 U/S 147/148/149/448/307/427/506/436/511 IPC and during interrogation he confessed that during occurrence of above noted crime he used one fire arms which he kept concealed in a bush beside his dwelling house. I noted the fact in GD vide Kashipur P.S GDE No 332 dtd 16.04.19. To verify his statement myself SI Goutam Kr Mahata along with JC/977 Tarun Kadam and JC/576 Avijit Goswami both of Kahipur P.S left P.S along with PC accd Bubai Hazra and reached at Kashipur Upar Para, under Kashipur P.S near the dwelling house of PC accd Bubai Hazra at 19.45 hrs. As shown, produced and identified by the PC accd Bubai Hazra I recovered (1) One improvised full iron made fire arms (Country made) having butt body barrel, trigger, firing pin etc, total length approx 10 inches, barrel approx 5.5 inches and butt approx 03 inches (2) One 8 mm live cartridge (Ammunition) from a bush from the east side of the dwelling house of PC accd Bubai Hazra. I demanded for relevant license/document from him in respect of above noted fire arms and ammunition, but he failed to produce any such valid documents in respect of the said fire arms and ammunition and could not give any satisfactory account in this regard which made him to believe that the accused person possessed that fire arms and ammunition illegally for some ulterior motive. On further interrogation he confessed that he along with co-accd persons in C/W Kashipur P.S Case No 20/19 Dt 16.04.19 U/S 147/148/149/448/307/427/506/436/511 IPC, went to the house of Sk Munna S/O Lt Sk Bagal of Kashipur Upar para, P.S Kashipur Dist Purulia for committing such crime. Accordingly I seized (1) One improvised full iron made fire arms (Country made) having butt body barrel, trigger, firing pin etc, total length approx 10 inches, barrel approx 5.5 inches and butt approx 03 inches (2) One 8 mm live cartridge (Ammunition), under proper seizure list in between 21.05 hrs to 21.45 hrs duly signed by witnesses and also by the accused person. I prepared label for the seized item. Accordingly after returning at PS, I produced the seized fire arms and live ammunition with all relevant documents.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused person Bubai Hazra (32 yrs) S/O Sadhan Hazra of Kahipur Upar Para P.S Kashipur Dist Purulia and to arrange for its investigation.
