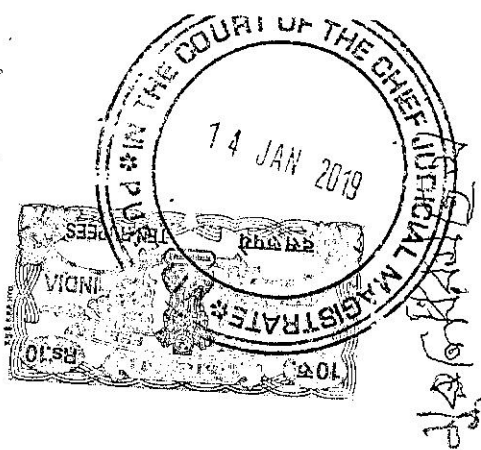

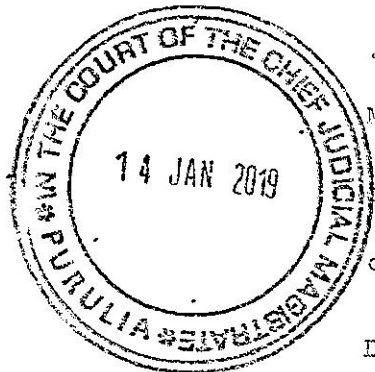

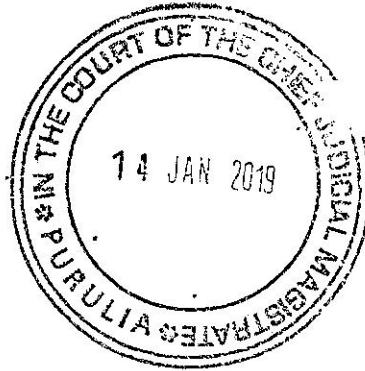

3) That I have ~~xx~~ started shouting here as Bachao, Bachao then the witnesses come to the spot and then the accused persons fled away and save my life.

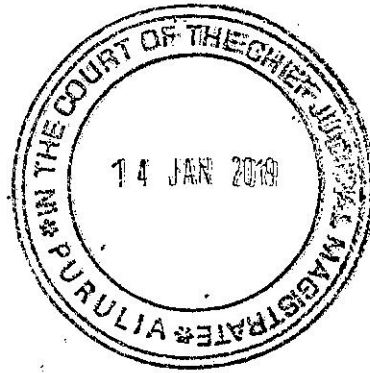
