



The above named complainant begs to state as follows :-

- 1) That the complainant is the resident of village Urusaram within P.S. Kotshilia dist. Purulia and within the jurisdiction of this court.
- 2) That on 09/11/2018 at about 12:30 O' clock husband of the complainant namely Mithu Mahato along with Naren <sup>PAYAMANIK</sup> Mahato the Anchari president of congress party went to village chitmu to join a meeting which was convened by the Anchari president the complainant heard from her husband that when they reached the Hari Mandir at chitmu then accused Sandip Khouwas running ahead with a revolver and threatened to kill them and Pankaj Gorain charged bomb in a little distance and all the accused persons gharoud them and assaulted them with fist blow and even hit them with the arms. accordingly husband of the complainant sustain heavy bodily pain escaped from the clutches of the miscreants and informed the matter to O.C. of Kotshilia, P.S. and treated him at kotshilia Hospital the doctor of Kotshilia P.S. referred the husband of the complainant to Purulia Sadar Hospital for better treatment.
- 5) That the O.C. of the said P.S. assured that legal action will be taken against the accused persons but no action has been taken from this ends accordingly the

complainant informed the matter to the S.P. Purulia on 12/11/2018 but no action has yet been taken as such the complainant is filing this petition before your Honour's court.
