Most respectfully begs to state :-


- That, the Complainant has married one Rahena Bibi D/o. accused Sk. Jakir of Hutmura on the other hand Accused Sk. Jabed married one Sajikun Bibi, sister of the Complainant of Tatari Village before about 4 years.
- 2) ____ That, after marriage, both couples were leading happy conjugal life at their respective houses.
- That, after one year of marriage, the accused sk. Jakir took his daughter Rahena from the house of Complainant assuring to bring back his daughter matrimonial house at Vill. Tatari but he kept his daughter in his house, on the other hand accused sk. Jakir, Sk. Jabed, Hanufa Bibi Rehena drove out Sajikun Bibi (sister of Complainant) from their house.
- That, the Complainant for several times went to his father-in-law's house at Hutmura to bring his wife Rahena but accused persons did not allow Rahena rather they forbad Rahena to came to her matrimonial house with her husband.
- That, on 14/03/2019 the Complainant went to nutmura to his father, in-laws house to bring his wire Conta.... Page No. 3.



Rahena and requested Accused Sk. Jakir. DR. Nejam and others to allow Rahena to come to Tatari. With the Complainant, but they did not allow rather they demanded 3 Talak of Rahena to which the Complainant did not agree of this bad proposal.

6) That, at about 6 P.M. all accused persons, with making a conspiracy attacked the Complainant started to assault by bamboo stick, fists, blows, kicks marcilessly, the accused Sk. Jakur and Sk. Nejam said "Salake Shes Kore De" and both accused tied the throat with intend to kill of the Complainant with very titly the Complainant by a napkin and they dragged. Ks The Complainant shouted "Bachoe, Bachao" When witness Sahabu adin and Jahir came txxxxx there and they saved the Complainant and kept him in side of Party Office at Hutmura from where they informed Police of Purulia(M) P.S. accordingly Police brought the injured Complainant to P.S. and sent him to Deben Mahato Sadar Mospital . Purulia where the Complainant treated there. The accused threatened the Complainant to finish him if any F.I.R. is lodged against them in Police Station.

7) That, the Complainant after discharge from
Hospital, lodged F.I.R. to Purulia(N) P.s. on 20/3/2019
but did not take any action again F.I.R. sent by xix
registered Post but no result. so, the Complainant



compelled to lodge, Complaint to S.P., Purulia on 27/03/2019 but no action yet been taken against the accused persons. Hence this Complain.

That, under the aforesaid circumstances it is clear that, all accused persons punishable U/s. 341/323/307/506/34 I.P.C., have jointly committed offences by assoulting by the Complainant by Lathi by fists and blows and kicks after confining him and attempted to kill the Complainant tied him tightly by napkin dragging him and so they should be punished.

Hence it is prayed that your Honour would be pleased to send this Petition of Complaint to the O/C. Purulia(M) P.S. for investigation U/S. 156(3) Cr.P.C. treating this as F.I.R.
