I, beg to draw your kind attention that I, Sumit Kumar s/o Shivprakash Ram resident of B.B.C. Road, P.O. Giridih, P.S. Giridih (T), Dist. Giridih, (Jharkhand) am the Registered Owner of Vehicle No. JH16A/6113 (Tipper Hiva) . On 31/3/2019 the said vehicle was proceeding towards Dhanbad from the side of Jamshedpur through N.H. 32. At about 5.30 a.m. the said vehicle was proceeding near Vill. Simulia under P.S. Purulia (M), Dist. Purulia and at that time one Trailer being No. NL 01Q/5846 was coming from the opposite direction in a very high speed and negligent manner. This said Trailer dashed my vehicle near Vill. Simulia.
