





The Complainant above named

Most respectfully begs to state:

That the Complainant is a permanent resident of Aligani, Medinipore, corinchas O.-Medinipore, P.S.-Kotwali, District-West-Medinipore, (W.B.), where she will purulish purulish





- That the Complainant is an owner of Mahindra & Mahindra, Bolero Pick-up Vehicle being No.WB-33D/2568. Which she purchased through hypothecation of HDFC Bank, Kharagour Branch.
- 3. That the Complainant & her husband Chayan Bera knew the Accused Persons for quite long time and by lapse of time a friendly relationship has been grown up in between the Complainant & the Accused Persons.

- That after purchasing the vehicle being No.WB-33D/2508 the Complainant plying the vehicle for earning livelihood but in the last part of 2017 she faced some difficulty in plying the vehicle and for that suffered some financial loss.
- That on coming to know about the matter in the first part of the year 2018. the Accused Persons approached the Complainant to handover the vehicle to them so that they can ply the vehicle on lease. They also assured to pay the amount for plying the vehicle on monthly rental basis.
- 6. That the Complainant found no other alternative & considering the offer of the Accused Persons hand over the vehicle to the Accused Person No.1 in presence of the Accused No.2 at Village-Muktapur, P.O.-Golbar, P.S.-Purulia (M), District-Purulia on 16/02/2018. At that time the Accused Persons assured to pay the rental amount on monthly basis regularly
- 7. That since thereafter the Accused Persons were plying the vehicle for business purpose within Purulia District & nearby districts of West Bengal. Initially the Accused Persons have paid some amount towards monthly rental of the said vehicle and at the same time the Accused Persons delayed to pay the rest rental amount on various pretext
- 8. That when such state of things were going on since the month of July, 2018 the Accused Persons have failed to pay the rental amount.
- 9. That during that period the mother of the Complainant suffered illness and the Complainant was busy for her treatment. But the mother of the Complainant died thereafter.
- 10. That thereafter the Complainant approached the Accused Persons for payment of the due monthly rentals but they delayed the payment on various pretexts.
- 11. That it is to be mentioned here that since 16/02/2018 the Complainant paid the monthly instalment amounts to HDFC Bank.
- 12. That when the Accused Persons failed to pay the monthly rental amount in respect of the said vehicle for quite a long time the Complainant came to the house of the Accused Person No.1, where both the Accused Persons were present & requested them (the Accused Persons) to pay the due amount and hand over the vehicle but the Accused Persons avoided the same.





- 13. That the Accused Persons even did not tell the whereabouts of the vehicle rather they threatened the Complainant with dire consequences if she asked for the vehicle further. It is to be further mentioned that the insurance of the vehicle is now failed due to non-showing the vehicle before the insurance authority.
- 14. That due to the activities of the Accused Persons the Complainant believes that the Accused Persons have illegally transferred/removed/concealed the vehicle and misappropriated the amount with intent to cause wrongful loss to the Complainant.
- 15. That the Complainant is a lady and for her financial stringency she has handover the vehicle to the Accused Persons, but the Accused Persons in-connivance with each other have cheated the Complainant with intention to cause wrongful loss to the Complainant by disposing the vehicle fraudulently. The Accused Persons involved in the illegal activity for their wrongful gain.
- 16. That the Complainant has informed the matter before the Inspector-in-Charge Purulia (M) P.S. on 19/03/2019 and also to the Superintendant of Police of Purulia but up-till now no step has been taken by the Police in the matter and for that reason the Complainant has filed this petition with a prayer for taking necessary action in the matter against the Accused Persons for their offences and also for recovery of the vehicle being No.WB-33D/2508 so that the Complainant can get relief in the matter.
- 17. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a complaint and send the same to the Inspector-in-Charge Purulia(M) P.S. with a direction to investigate in the matter as per provision of the Section-156(3) Cr. P.C. and further be pleased to pass necessary order.
