Sir,

In producing herewith one accused person namely Miten Bauri (42 Yrs.) S/o Lt. Nepal Bauri of Vill.- Mandapdanga, PS – Raghunathpur, Dist.- Purulia under arrest along with seized (1) 28 (Twenty Eight) sealed bottles (CS) containing 600 ml each and labeled with DILSE and (2) One plastic bag, I ASI Prabir Kr Dey of Raghunathpur PS beg to submit that today (26.04.19) at about 14:05 hrs during my day mobile duty received a source information over telephone that the above noted accused person has been stocking & selling liquor illegally & clandestinely of his Pan Stall at Mandapdanga village more on Chelliyama – Raghunathpur Road. On receiving the reliable source information I communicated with I/C Raghunathpur PS over telephone and as per his instruction I along with force rushed to the spot to work out the information. On arriving to the Pan Stall of above noted accused person at Mandapdanga village more, I apprehended the above noted person after a strong attempt and four customers seeing the Police party managed to escape. On close interrogation the apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid documents in support of stocking & selling that illicit liquor but he failed to produce any legal paper/document in support for stocking & selling such liquor. Accordingly I seized above noted seized articles after preparing proper seizure list and duly signed by the accompanying party and the labeled one bottle as sample. After this I arrested the accused person namely Miten Bauri (42 Yrs.) S/o Lt. Nepal Bauri of Vill.- Mandapdanga, PS – Raghunathpur, Dist.- Purulia after observing all the formalities regarding arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the arrested accused person namely Miten Bauri (42 Yrs.) S/o Lt. Nepal Bauri of Vill.- Mandapdanga, PS – Raghunathpur, Dist.- Purulia under proper section of law and arrange for its investigation.
