The complainant most respectfully beg to
state:-

1. That the complainant and the accused persons are the inhabitants of the same village i.e. Chalgan (Halla) under Rajmangal P.S. within the Dist. of P. (U.S) and neighbour to each other.
2. That since last two years the accused persons have been trying to acquire a strip of land out of the house plot of the complainant illegally and forcibly by various means, but unable to do so have obstructed vehemently by the complainant and his family members.
3. That due to aforementioned reasons the accused persons have always lodged against the complainant & his family members and always trying to do mischief & irreparable loss and injury to the person & property of the complainant.
4. That it is to be admitted that by the time the accused person has been nominated by the village of Chalgan (Halla) as the secretary of Rajmangal committee and the Secretary of Sagarika committee by the village of Chalgan, P. (U.S) of the locality.
5. That on account of the accused persons being nominated as secretary of Rajmangal committee & P. (U.S) committee, he has been indulging in various activities against the complainant and his family members and on account of the complainant being the secretary of Sagarika committee, he has been indulging in various activities against the complainant and his family members.

6. That on ^{the} strength of above, the complainant on 8 from the month of August issued a Fatwa of boy-cott/ ^{in the month of August} protest against the complainant and for the people of his area, that no one of his area will maintain any social or domestic relation with the complainant and his group.

7. That in pursuance of that "Fatwa" the complainant and his group has been debarred from performing religious ceremonies and take part in any way execution of ceremonies, even the complainant & his relatives are debarred from entering into masjid (Temple)

8. That apart from the above, the complainant has also debarred the Maulana of the above said villagers that they will also will not be able to take part in any religious ceremonies in the residence of the complainant and his group.

9. That by the above said illegal act of the above persons the complainant and his group has been facing too much mental agony and difficulties in passing their daily domestic routine works, Moreover the peace and public tranquillity has been seriously disturbed and there is every apprehension of breach of peace at the instance of the above persons.

10. That the complainant tried to resolve and pacify the matter stated above with the intervention of the local group of all persons but in no good, hence the complainant has been compelled to take shelter of law.

11. That in pursuance of the above the complainant lodged complaint before the O/C Rajmasthan P.S. on 09-01-19 and on 11-01-19 the O/C Rajmasthan P.S. took no action, the complainant lodged complaint before the S.P. Panchi on 24-01-19 in spite of that no action has been taken by the O.C. Rajmasthan P.S.
