

The complainant most respectfully showeth:-

1. That the complainant and the acced. persons are the co-Villagers and inhabitants of same village: Matidundra under Neturia P.S. within the jurisdiction of your Hon's court.

- 2. That at the relevant day celebration of Goddes "MAA SARASWATI" was going on in the village.
- 3. That on the date of occurrance on 16-02-19 at about 7-30/8-00 P.M. a procession for immerssion of Saraswati Devi was proceeding towards the Tank through Kuli rasta under the leadership of the acced.person. ✓
- 4. That it is to be submitted that in the said procession there were D.J.Mike, Band Party etc. were in active operation in a high voltage of sound and while the said procession came in front-joutdoor of the complainant the acced.persons willfully with an illmotive stayed the procession and started dancing on the kuli Rasta.
- 5. That it is to be further submitted that at the relevant days examination of H.S. Examination were in process and a causion sister of the complainant was taking preparation in the house of the complainant who was feeling much disterbances through the above said illegal act of the O.P. member.
- 6. That in persuance of the above said reason the complainant came out from his residence and requested the complainant to go ahead with their procession but the acced. persons became furious and all of them wrongfully, forming unlawful assembly caught hold the complainant and over powered him and dashed his head with a wheel made of iron forcibly, as a result cut the complainant sustain severe and bleeding injury on his head.

7. That apart from the acced. person sassaulted the complainant by fist and blows out of which the complainant sustained swelling and severe pain injury on his body.



8. That it is to be submitted that the above said bullock cart was kept by the side of Kuli Rasta infront of the residence of the complainant.

9. That the witnesses and the neighbour resquete the complainant and took him to super speciality Hospital Raghunath pur for treatment where from the complainant was referred to B.S. Medical College & Hospital Bankura for treatment.

10. That getting recovery the complainant lodged complain before Santuri Police Station on 26-02-19 through Regd . Post with A/D.

11. That inspite of complain lodged before 0/C Santuri P.S., the police Santuri P.S. took no any action against the acced. person. Thereafter the complainant lodged complain before S.P. Purulia on 11-03-19 still then no action has been taken as yet. Hence the complainant come before your Honour for redressal.

In view of the facts & circumstances it is prayed that the present complain petition may kindly be sent to O/C Santuri P.S. for investigation treating the petition as F.I.R. U/S 156(3)Cr.P.C. for ends of justice.
