In producing here with one arrested accd namely Ritesh Kumar @ Mukesh Kumar (25) S/O Sir, Amrit Kumar of Vill- Satra P.S.-Arsha Dist-Purulia along with following seized articles as noted below-

- 1) 12 (twelve) bottles of "DIL KHUSH" country spirit each of 375 ml and value Rs 22/- each
- 2) 10 (ten) bottles of "DIL KHUSH" country spirit each of 600 ml and value Rs 35/- each

I, SI Mani Sankar Mahanta of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 26.05.19 at about 08.35 hrs during my mobile duty received source information over telephone that the above noted accused is selling liquor illegally and clandestinely at Satra village under Arsha PS, Dist- Purulia. On receiving the reliable source information I communicated with O/C Arsha PS over phone and as per his instruction I along with force of Arsha PS, C/250 Ananda Rana of SAP 7th Bn. A/P Camp at Arsha PS and C/ 1177 Samir Das of Arsha PS rushed to the spot to work out the information. Reaching at Satra at 09:00 hrs. we fixed-up the house of above noted accused person and noticed that he was selling country spirit and seeing the police approaching, all persons started to flee away. But after a brief chase we were able to apprehend the above noted accused person. On demand he failed to produce any valid documents in support of stocking and selling country spirit "DIL KHUSH". So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labelled duly signed by the accused persons and witnesses among 01 (one bottle) of each i.e. of 375ml and 600ml of "DIL KHUSH" were kept as sample file with label. During interrogation he confessed his guilt, so I arrested him after observing all the formalities issuing memo of arrest as the accused person is liable for prosecution under proper section of law.

I therefore pray that a specific case may kindly be started against the accused namely Ritesh Kumar @ Mukesh Kumar (25) S/O Amrit Kumar of Vill- Satra P.S.-Arsha Dist-Purulia under proper section of law and arrange for its regular investigation.
