Sir.

In producing herewith the accused Alam Ansary (36 Yrs), S/O-Tabarak Ansary of Vill-Raghunathdih, P.S-Baghmundi, Dist-Purulia, before you and with one improvised fire arms having 11.05 cm length (Approx) iron Butt, body, firing pin and triggered as working condition with one live cartridge sealed and labeled which were seized from his possession. I, ASI Narayan Mukharjee of Bagmundi PS am to state that Today (05.05.19) during my evening mobile duty vide GDE No-166, Dtd: 05.05.19 and CC No-2261/19 received a secret source information that the above noted person possessed a "Saman" (a improvised pipe gun) with him and was wondering at Duarsini More. On getting the tip off, myself along with 1) C/ 564 Prasad Majhi,2) C/1454 Ashok Kumar Mahato of Baghmundi PS rushed to Duarsini More to work out the same. On arrived and kept the Govt hire vehicle bearing no WB55A/5600 in a distance and being assisted by some local people detained the said Alam Ansary (36 Yrs), S/O-Tabarak Ansary of Vill-Raghunathdih, P.S-Baghmundi, Dist-Purulia at Duarsini More and searched him and found one Improvised fire Gun loaded with one live cartridge from the back waist of that person. I safely took out the gun from his waist and unloaded the gun safely after keeping the local people in safe distance. On asked he failed to give any satisfactory account in support of possession of that Improvised gun with him and could not produce any valid document/Paper in support of it. Moreover on asked, he made different statement in different time. So I arrested him informing him the ground of arrest and seized the one improvised fire arms of 11.05 cm length (Approx) iron Butt , body, firing pin and triggered as working condition with one live cartridge sealed and labeled by the witnesses and accused person. So I took Alam Ansary (36 Yrs), S/O-Tabarak Ansary of Vill-Raghunathdih, P.S-Baghmundi, Dist-Purulia, in custody and the seized fire arms and ammunition as alamat and brought him to PS and produced before you.

Under the above circumstances I am pray before you to start a specific case under proper section of law against Alam Ansary (36 Yrs), S/O-Tabarak Ansary of Vill-Raghunathdih, P.S-Baghmundi, Dist-Purulia, and obliged.
