





### Most respectfully beg to state:

- 1\_ That the Complainant is the legally married wife of the Accused Person No.1 and the Accused Person No. 2 & 3 are the Parents-in-law of the Complainant.
- 2\_ That the Complainant is the legally married wife of the Accused No.1 and their marriage was solemnised on 21st day of Falgun, 1424 B.S. corresponding to 06/03/2018 at Village Gobindapur within Bagmundi P.S. & Purulia district as per Hindu rites and customs prevailing in their community after negotiation.
- 3\_ That at the time of marriage the father of the Complainant has given cash of Rs.80,000/-, golden & silver ornaments, and furniturs, utensils & other things amounting to Rs.51,000/- as per demand of the Accused No.1 & his parents who are the Accused Person Nos.2 & 3. After the marriage the Complainant came to her matrimonial home at Village-Maulia, P.S.-Bagmundi, within Purulia district to lead a conjugal life with the Accused No.1.
  - 4\_ That at the matrimonial home the Complainant found that her husband always in contact with one Satyabati Kumar of Village-Majhidi, P.S.-Jhalda, District-Purulia. On query of the Complainant, her Parents-in-laws informed her that the Accused No.1 has love affairs with said Satyabati Kumar and for money they have given marriage of the Accused No.1 with the Complainant.
  - 5\_ That when the Complainant asked her parents-in-laws why they have cheated the Complainant by given in marriage of the Accused No.1 with her, by suppressing such matter, the Accused Persons started to ill treat and physically tortured the Complainant.
  - 6\_ That thereafter the Accused Persons always tortured the Complainant both mentally and physically. The torture upon the Complainant increased day by day. The Complainant bore all such ill-treatment and torture with a hope that in future the Accused Persons mend their behaviour but her all such expectation went in vain.
  - 7\_ That after passing of about six months, the Accused No.1 brought said Satyabati Kumar on 12/10/2018 at matrimonial home with a view to keep her. On the protest of the Complainant over such illegal act the Accused Persons severally assaulted the Complainant and tried to drive her out from the matrimonial home. The Complainant somehow requested them not to drive her out as she assured that she will not raise any protest further and thereafter they allow her to stay at the matrimonial home.
  - 8\_ That on 14/10/2018 when the father of the Complainant went to the matrimonial house of the Complainant on the occasion of Durga Puja, in his presence the Accused Persons assaulted the Complainant. On witnessing such situation, to save the Complainant, the father of the Complainant brought her to his house at Village Gobindapur.
  - 9\_ That there after the father of the Complainant tried to solve the dispute but due to the adamant attitude of the Accused No.1 his all such action went in vain. The Accused No.1 has also abused him. He also never came to the paternal house of the Complainant to bring back the Complainant.
  - 10\_ That during her stay at the matrimonial home the Accused No.1 did not provide two square meals to the Complainant and she has to do all the domestic works as maid servant.



- 11\_ That the Complainant since 14/10/2018 lives at her father's house and now extra burden over her poor father. At present the Complainant is a helpless lady and the Accused Persons do not want to keep her at the matrimonial home.
- 12\_ That the Complainant thereafter informed the matter to the O/C Bagmundi P.S. requesting him to take legal steps against the Accused Persons but the police did not take any action in the matter up-till now.
- 13\_ That the Complainant also informed the matter to the S.P. Purulia but up-till now no action has been taken by the police.
- 14\_ That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Bagmundi P.S. for investigation & further be pleased to pass necessary order.
