In producing here with 03 (three) arrested accused person namely 1) Yudhistir Mahato (59yrs) S/O- Lt. Durga Charan Mahato of Chakulia, PO-Berada, P.S.- Balarampur, Dist. Purulia 2) Gunadhar Mahato (35yrs) S/O- Brindaban Mahato of Vill-Pokhoria,Tola-Baghbera, PS-Boram, Dist-Singhbhum (JKD) 3) Ambuj Mahato (42 yrs) S/O- Lt. Charan Mahato of Vill- Berada, PO-Berada, PS-Barabazar, Dist-Purulia along with following seized articles viz-

- 1) 19 Ltrs (Approx) of country spirit contained in a container.
- 2) 300 grms (Approx) NISHADAL.
- 3) Thirteen pieces of plastic glass.

I ASI Prabir Mukherjee of Balarampur P.S do here by lodged a complaint against accused persons namely 1) Yudhistir Mahato S/O- Lt. Durga Charan Mahato of Chakulia, PO-Berada, P.S.- Balarampur, Dist. Purulia 2) Gunadhar Mahato S/O- Brindaban Mahato of Vill-Pokhoria, Tola-Baghbera, PS-Boram, Dist-Singhbhum (JKD) 3) Ambuj Mahato S/O- Lt. Charan Mahato of Vill- Berada, PO-Berada, PS-Barabazar, Dist-Purulia to the effect that today (21.05.2019) at about 15:45 hrs in course of my mobile duty I received a telephonic information from a reliable source that 3/4 persons have stocked some illicit liquor at Chakulia jungle area under Balarampur P.S & selling the same to innocent people for their personal gain. Accordingly I informed the matter to O/C Balarampur PS & as per his order I along with force held raid at the Chakulia jungle area (as shown by source) and found that 03 (three) persons were mixing the country spirit contained in 20 ltr. container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, beside the jungle area of Chakulia village. Accordingly I detained those 03 (three) persons who recognized themselves as 1) Yudhistir Mahato S/O- Lt. Durga Charan Mahato of Chakulia, PO-Berada, P.S.- Balarampur, Dist. Purulia 2) Gunadhar Mahato S/O- Brindaban Mahato of Vill-Pokhoria, Tola-Baghbera, PS-Boram, Dist-Singhbhum (JKD) 3) Ambuj Mahato S/O- Lt. Charan Mahato of Vill- Berada, PO-Berada, PS-Barabazar,

Dist-Purulia. Being interrogated they confessed that the white powder like substance is NISHADAL, an intoxicated substance having acrid smell which is likely to cause disability or death to human being. It is also revealed during interrogation that above noted 03 (three) persons were selling the illicit liquor mixing with NISHADAL with a view to cause physical disability or death to human being. So, I arrested the above mentioned accused persons namely 1) Yudhistir Mahato S/O- Lt. Durga Charan Mahato of Chakulia, PO-Berada, P.S.- Balarampur, Dist. Purulia 2) Gunadhar Mahato S/O- Brindaban Mahato of Vill-Pokhoria, Tola-Baghbera, PS-Boram, Dist-Singhbhum (JKD) 3) Ambuj Mahato S/O- Lt. Charan Mahato of Vill- Berada, PO-Berada, PS-Barabazar, Dist-Purulia maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accused persons and available witnesses.

Hence, I, therefore pray that a specific case may kindly be started under proper section of law against arrested accused persons namely 1) Yudhistir Mahato S/O- Lt. Durga Charan Mahato of Chakulia, PO-Berada, P.S.- Balarampur, Dist. Purulia 2) Gunadhar Mahato S/O- Brindaban Mahato of Vill-Pokhoria, Tola-Baghbera, PS-Boram, Dist-Singhbhum (JKD) 3) Ambuj Mahato S/O- Lt. Charan Mahato of Vill- Berada, PO-Berada, PS-Barabazar, Dist-Purulia and arrange for its investigation.
