At the onset we would like to introduce our profile as a company, we are a solar implementation organization and we install solar panels to I.P. and Telecom operators in the states of West Bengal and also take care of entire end to end processes and do after operations maintenance activities too.

We would request your attention regarding the above mentioned subject with reference that Mr. NitaiGope the grandson of Mr. ManoharGope has been taken forcibly the site's key as above mentioned during operation and maintenance work was doing by me in night on 23.03.2019 and capture the site. The site yet to get electrified due to objection given by Mr. NitaiGope after done all formalities between Indus and W.S.E.D.C.L. in the year of 2016 and so the site is running on Diesel Generator and solar panel.

We are unable to operate and maintenance the site on regular interval because of Mr. NitaiGope does not give the key as required for said work, the site became down due to deficient of diesel in generator. Mr. NitaiGope demand diesel beyond the requirement and blackmail us as the site goes down and we are facing such problem because we have to keep site on to provide telecom services at that entire area, we are also unable to maintain all equipment's which needs in regular interval. All equipments are costly and sensitive.

Our request you to please lodge the F.I.R. and do the needful as required.
