Sub: Prayer for starting a specific case under proper section of law.

Sir,

In producing herewith one seized truck bearing no – JH 10S/3517 loaded with raw coal of 14 M.T. (approx) do hereby lodge a complaint to the effect that on (05/05/19) myself along with C/1224 Gajan Murmu and C/1304 Dhananjoy Mondal all of Neturia PS were engaged in anti crime night mobile duty vide Neturia PS GDE No- 193 Dt. 05.05.19 & CC No- 1133/19 Dt. 05.05.19. In course of night Mobile Duty, at about 22:15 hrs when we reached near Mekatola More, I received an credible source information to the effect that one truck bearing No JH 10S/3517 loaded with illegal coal coming from Raghunathpur side and will transport the same to Asansol side through Purulia - Barakar road in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started naka checking there to intercept the vehicle. During naka checking we found that one truck which was coming from Raghunathpur side suddenly stopped about 70/80 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards dark side beside the road. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding area with torch light to find out the person but failed to trace out him. On search we found that the truck having Regd. no – JH 10S/3517 was loaded with raw coal of 14 M.T. (approx) and the key of the truck has been left away in the truck by the driver.

So, there is reason to believe that the driver, owner of coal and registered owner of the said vehicle have collected the said coal either by theft or by any fraudulent means and after hatching a criminal conspiracy, they are trying to dispose of the same coal in a clandestine manner to Asansol side knowing it to be stolen, as per their regular practice.


Accordingly I seized the said truck bearing no – JH 10S/3517 loaded with raw coal of 14 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 22:35 hrs and 22:55 hrs, since no public witness was found.

Under the above circumstances a specific case may kindly be started against the (1) driver of truck bearing registration No – JH 10S/3517 (2) owner of the coal, seized from truck bearing registration No – JH 10S/3517 and (3) Registered owner of truck bearing registration No – JH 10S/3517 under proper section of law.
