 I am writing to you regarding the incident on 20.05.2019 at 11:00 AM. I was driving my car (Model: Maruti Suzuki Swift, Reg. No. WB-17-AB-1234) on the road from Purulia to Kolkata. At approximately 11:00 AM, I was stopped by a group of about 10-12 individuals who demanded money and threatened to harm me and my family.
