I THE UNDER SIGNED BEING THE ILL FATED BROTHER OF RAMESH SARAWGI, S/O SURESH KUMAR SARAWGI A RESIDENT OF TANTI PARA, WARD NO. 4, PO.+P.S. :RAGHUNATPUR, DIST: PURULIA, WOULD LIKE TO LODGE THIS COMPLAIN THAT ON 03.05.2019 AT ABOUT 10.00 AM WHILE MY BROTHER RAMESH SARAWGI WAS PROCEEDING TOWARDS ANARA SIDE WITHIN PURULIA DISTRICT BY HIS OWN VEHICLE NO. JH10AZ6516 (MARUTI SWIFT) NEAR MAHULA MORE ON PURULIA BARAKAR ROAD, UNDER RAGHUNATHPUR P.S., A VEHICLE BEING NO. WB82B8433 (SCORPIO) WHICH WAS COMING FROM OPPOSITE SIDE THAT IS FROM PURULIA SIDE AND PROCEEDING TOWARDS RAGHUNATHPUR IN A RASH AND NEGLENT AND ZIGZAG FASSION MANNER DASHED THE VEHICLE OF MY BROTHER CAUSING GREIVIOUS INJURY TO MY BROTHER, RAMESH SARAWGI AND BADLY DAMAGED THE VEHICLE OF MY BROTHER.

THE ACCIDENT HAPPENDED DUE TO RASH AND NEGLENT DRIVING ON THE PART OF THE DRIVER OF THE VEHICLE NO WB82B8433 (SCORPIO).
