

The complainant most respectfully beg to state :-

1. That the comp is the Hindu married wife of acod.No.1 and the marriage was solemnised in between them in the year 2013 an per their customs prevailing in their community and due to the said wed-lock a son was begotten who is now four years of age.


2. That the aced.No.2 is the elder brother in-law-( Bhasur) and the aced. No.3 is the " Jya" wife of elder brother -in-law of the complainant.

3. That at the time of marriage the parents of the petitioner fulfilled the demand i.e. Rs. 1,20,000/- in cash ,goldent and silverornaments as dowry demand and other bridal gifts i.e. farurniture, utensils , clothes etc made by the aced. persons.

4. That after the marriage the complainant was taken to her in-laws house and started marital life but she was never accepted with love and dignity after ~~three~~ <sup>two</sup> years of her marital life the complainant fell victim of ~~teasing~~ mental and physical torture for not bringing extra demand of dowry of Rs. 1,20,000/- from her fathers house . The marital life of the complainant has been ful of pangs and the behavibour of the accused person causes immense mental pain but the complainant had to swallow all such indignity silently for her future life.

5. That tarture <sup>gradually</sup> ralled upon the complainant her congugal happyness went into flame sheexperienced a bitter test of marital life being the victim of persistant farture both physicaland mentally from the part of the aced. person and finding no other alternative she was compelled to leave her matrimonial home and took shelter at her father's house <sup>on</sup> and from 15-01-2019

6. That on 20-1-2019 while the complainant was in her father's house all the aced.persons came to the father's house of the complainant and in order to materialise theircommon intention they started to abuse the complainant in filthy languages <sup>and</sup> on being protest against such illegal and overt act

the accd. persons grew furious and assaulted the complainant with fists and blows.

7. That by the help of the witnesses the complainant anyhow save herself from the evil clutches of the accd. person. The witnesses also protested against the illegal act of accd. person and finding no other alternative accd. persons had left the P.O. with a threatening that they will murder of the complainant if she goes to her matrimonial house and for that the complainant could not dare to go her matrimonial house.

8. That the complainant reported the the incident to the local P.S. at Adra on 24-1-2019 against the accused persons but the said P.S. did not take any legal against the accused persons then on 29-01-2019 she reported the matter to S.P. Purulia District- Purulia <sup>but</sup> she did not get any legal remedy.

9. That as such finding no other alternative complainant with her folded hand seeking her remedy before the Ld. court for the offence caused by the accd. persons.


10. That from the forgoing paras it is crystal clear that accd person have committed the offence u/s. 498(A)/506/34 I.P.A and 3 & 4 D.P.Act.

11. That the complainant is a poor lady having no financial capacity to defray in day to day expenditure of the court.


