I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Kala Kumar, S/O- Late Hazari Kumar of village Gobindapur, P.O- Radha Gobindapur, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 15/06/2019 at about 11:00 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Subhasis Mahato, OE, Bagmundi CCC, WBSEDCL 2. Abdul Hasib, LM, Bagmundi CCC, WBSEDCL, entered the premises of Sri Kala Kumar, S/O- Late Hazari Kumar of village Gobindapur, P.O- Radha Gobindapur, Dist- Purulia and found Sri Kala Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Kala Kumar S/O- Late Hazari Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Subhasis Mahato, OE 2. Abdul Hasib, LM. The inspection team left the premises at 11:10 a.m.
