On 15/06/2019 at about 11:35 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Subhasis Mahato, OE, Bagmundi CCC, WBSEDCL 2. Abdul Hasib, LM, Bagmundi CCC, WBSEDCL, entered the premises of Sri Mahadeb Kumar, S/O- Late Sahadeb Kumar of village Gobindapur, P.O- Radha Gobindapur, Dist- Purulia and found Sri Mahadeb Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Mahadeb Kumar S/O- Late Sahadeb Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Subhasis Mahato, OE 2. Abdul Hasib, LM. The inspection team left the premises at 11:50 a.m.
