In producing herewith arrested accused Dilip Ghasi (27 yrs) S/O- Rashu Ghasi of Vill.- Ghatbera (Namopara), P.O.- Ghatbera, P.S. - Balarampur, Dist - Purulia and brought under seizure

1) One improvised iron made, country made pipe gun having length about 8 ½ ", having iron Butt length about 4 1/2", having trigger, firing pin, 2) One improvised iron made, country made pipe gun having length about 8 ½ ", having iron Butt length about 4 ½", having trigger, firing pin, 3) 08 (eight) live ammunition (8 MM) in unloaded condition, 4) one white colour dirty hand bag under proper seizure list duly signed by the witnesses as well as accused person. I do hereby lodge a complaint to the effect that in course of evening mobile duty at 21:06 hrs. I received a information from my source that 01 (one) person namely Dilip Ghasi S/O- Rashu Ghasi of Vill.- Ghatbera (Namopara), P.O.- Ghatbera, P.S. - Balarampur, Dist -Purulia get a contract for supplying arms & ammunition, and in this regard they will pass through Urma Railway crossing towards Karma village along with some arms & ammunition to supply the same on 21.06.19 at approx 21:06 hrs. Accordingly I informed the matter to O/C Balarampur P.S. and as per direction of O/C Balarampur PS myself along with accompany force along with source reached near Urma Railway crossing and kept the vehicle in a safe distance and proceeded at the turning towards the Kachha road of Karma village on foot and ambushed. At about 21:45 hrs we found 01 (one) person coming from Karma village side on kachha road. We intercept him at Ghatbera village more. On being asked he disclosed his identity as noted above. On through search on his person, we found 02 (two) improvised iron made pipe gun each having length approx $8^{1/2}$ ", having iron but trigger, firing pin found in a hand bag along with 08 live ammunition (8 MM). On being asked he failed to produce any valid license or authority for the said arms & ammunition which is found his possession or which arms & ammunition he carrying. So I seized the said arms & ammunition under proper seizure list duly signed by the witnesses as well as arrested him monitoring all the guide line regarding arrest. No public witnesses could be available there.

Under the above fact and circumstances, I therefore pray before you to start a specific case under proper section of law against Dilip Ghasi (27 yrs) S/O- Rashu Ghasi of Vill.- Ghatbera (Namopara), P.O.- Ghatbera, P.S. - Balarampur, Dist - Purulia and obliged.
