 - 3. That at the time of marriage the father of the petitioner has given Rs.3,00,000/- as dewry money to the epp.party members as per their demands gold and silver ornaments and other household article's were also given to the opp.party members.
 - 4. That after marriage the petitioner went to her matrimonial house at Village-Berma and lived with the epp.party No.1 as

husband and wife .

- 5. That out their wed-lock a male child was born who is aged about 3 years.
- 6. That since after marriage the opp.party members started torture upon the petitioner both physically and mentially, and they also did not provide sufficients food, clothings and other essentials to the petitioner. The opp.party members xrankriated 2,3 and 4 instigated the opp.party No.1 to assult the petitioner Sachita Kalindi. The opp. party No.1 on his turn assulted the petitioner mercilessly and lastly drove her from her matrimonial house.
- 7. That having no other alternative the petitioner tank took shelter to his father and till date she is residing at her father's house.
- 8. That the opp.party No.1 filed a Matrimonial suit being No. 66 of 2016 before the Court of the Ld.District Judge, Purulia and now the said matrimonial suit is pending in the Court of the Ld.Addl.Dist.Judge-3, Purulia.
- 9. That the petitioner learnt from reliable source on 22-6-2019 in connivance with other opp.party members that the opp.party No.1 has married for the second time to a a girl probably the resident of Village-Tentlo and committed the offence of Bigamy.
- 10. That the opp.party members have committed the offence U/S #2 498A/494/34 of I.P.C. and Section 3/4 of Dowry Prohibition Act.
