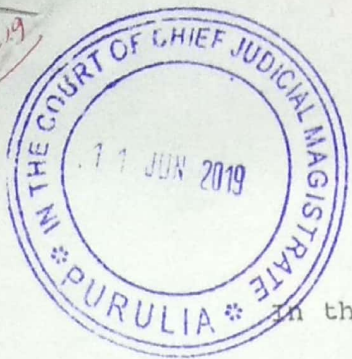

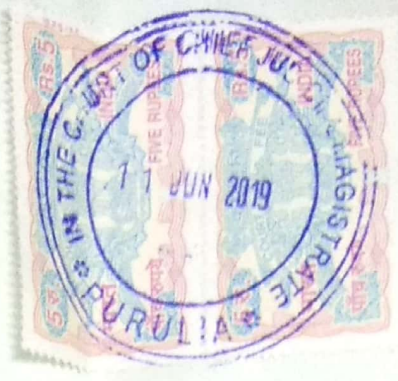

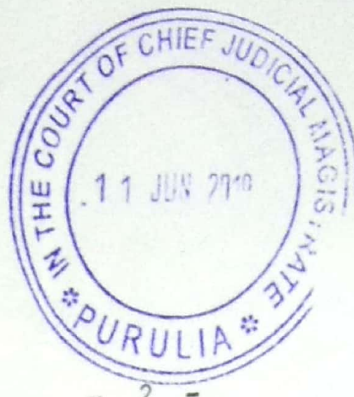

Facts of the case :-

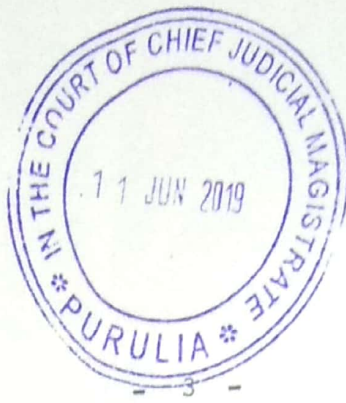
The above named complainant

Begs to state as follows :-

1. That the complainant has been married with the accused No.1 which was held on 22/06/2018 (07th day of Ashar 1425 B.S.) at Village- Jaharhatu within P.S.- Kotshila as per Hindu Rites and customs of the parties.
2. That the marriage was/is a negotiated marriage and as per demand of the accuseds the father of the complainant was compelled to pay case Rs. 1,55,000/- and various articles viz. gold chain, gold jhumka, silver tora, Nupur, Divan, Sponge bed, Almira, Freez, Coller, Dressing table, LED TV, Gas cylinder and oven, Alna, Mixture grinder, Pressure cooker, Kitchen set, Gagra Kansa 2, Pital Hari-2, Aluminium Hari- 2, Steel Hari- 2, Ghati, Glass, big size Kansa thala- 1 and ~~another~~ ^{of thala} of several sizes, 10, pital balti 7, Aluminium balti- 7, steel balti- 7, chair-2, Jhari- 1, perat - 2, steel-chaki-balna , Karai, Ketli, Box and many other articles in all the cost of marriage is about five lakh, the father of complainant paid the money and so many articles as the accused No.1 is the only son and a Civil Police.

3. That after marriage the complainant went to the

house of the accuseds but the accuseds were not satisfied in the articles given in the marriage and they started to abuse in so many languages to the complainant and her parents.

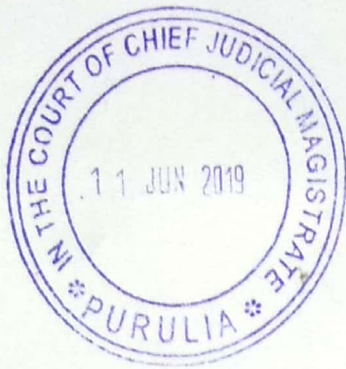
4. That on 25/06/2018 as per custom the complainant along with accused No.1 her husband went to the house of the father of the complainant, and in the said evening as per desire of the accused No.1 she went to her husband's house.

5. That on that night the complainant took part bed with her husband but the accused No.1 ~~but he~~ was not ^{interested} ~~interested~~ for sexual intercourse rather he was impotent at that time the complainant asked why he has married when the accused No.1 initially kept mum but subsequently disclosed that he has married her only to get the money and articles, ^{as} ~~though~~ he is Civic Police.

6. That the complainant every morning used to cry when the accused No.3 her mother asked about the reasons of ~~mother's~~ crying in reply the complainant disclosed why they have given the marriage of their son to spoil her life.

Hearing the same all the accuseds started to abuse the complainant in so many filthy languages and used to say the complainant as a characterless woman.

7. That the complainant informed her mother about the

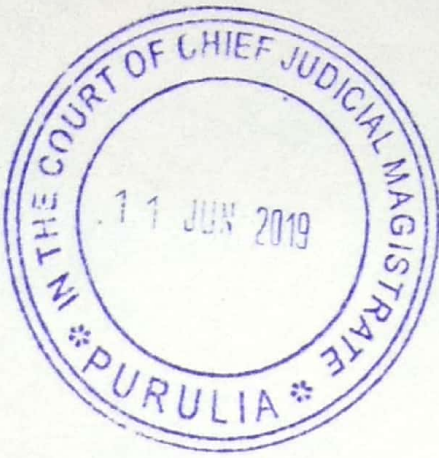
the above facts over telephone, however the days were passing after bearing so many torture even ~~they~~ ^{she} did not take ^{any step} when she was suffering from fever and even ~~the~~ ^{her} ~~acc.~~ ^{no.1} did not take step for his treatment of impotency.

8. That ultimately on 22/07/2018 the complainant was compelled to leave the house of the accuseds on 22/07/2018 as her brother and maternal ~~uncle~~ ^{uncle} / Mesomasai took her to her father's house at Village- Jaharhatu and ~~give~~ since then she is residing at her father's house.

9. That all the accuseds knowingfull well about impotency of the accuseds No.1 got the marriage solemnised demanding cash money and articles they have cheated the complainant and her parents and even after marriage they were not satisfied in dowry and abused her and her parents in filthy languages and have tortured her for which she has been compelled to take shelter in her father's house.

10. That the complainant stating every facts lodged information to I.C. Jhalda but as he did not take any step again on 16/02/2019 sent registered information which was received on 18/02/2019 but no step was taken ^{and} on 01/03/2019 information was given to S.P. Purulia but till this day case has yet not been started for which this petition is filed before the Ld. Court.

11. That the accuseds have committed cheat^{ing} and practiced ^{fraud} upon the complaint and tortured her in various ways and also committed the offence of the provision of Dowry Prohibition Act for which they should be ^{adequately} punished.
