

Sir,

In producing herewith one arrested accused namely Asamul Ansary @ Chand (28), s/o- Usman Ansary of vill- Metyal sahar, PS- Adra, Dist- Purulia, West Bengal with Arrest Memo, seizure list, other related papers and seized articles such as one iron made single bore country made firearms having length of 25 cm (approx) with butt, barrel, firing pin, trigger etc. The length of the barrel is 11.5 cm (approx) and one live ammunition of 8 mm under proper seizure list and being labeled properly, I beg to inform you that today (27/06/19) during my anti crime mobile duty at Kashipur bazar area vide Kashipur PS CC No- 992 Dtd-27/06/19 & GDE No-906 Dtd-27.06.2019 at 18.05 hrs received a telephonic information from my reliable source that one youth aged about 28 years was seen loitering at Sabji bazaar (weekly hat) under Kashipur PS and a careful observation from the close point of view something like the butt of a small firearms was seen at his waist being kept supported with his pant and it was his firm belief that it was nothing but a fire arms . I asked him to keep eye upon the suspicious person and consulted with O/C Kashipur PS over telephone about this matter and as per his direction at 18:15 hrs, I along with JC/576-Avijit Goswami, NVF/1048-Kashinath Mahato of Kashipur PS started for working out the information from Rajbari more after briefing them properly about the gravity of the information and my plan to nab him. We reached at Sabji bazar at around 18:25 hrs and keeping the vehicle parked in a safe place we proceeded to the spot on feet. On reaching there, my source identified the person by gesture from a distance and we apprehended one youth at 18.35 and on asked he identified himself as Asamul Ansary @ Chand (28), s/o- Usman Ansary of vill - Metyal sahar, PS - Adra, Dist - Purulia, West Bengal and I disclosed him about the information and on searching one iron made single bore country made fire arms having length of 25 cm (overall approx) with butt, barrel, firing pin, trigger etc has been found. The length of the barrel is 11.5 cm (approx) and was recovered from his exclusive possession and on opening the fire arms one live ammunition of 8 mm was recovered as being loaded in the fire arms. On asked he failed to produce any constitutional papers in support of possessing or keeping the fire arms. I took a pictorial diagram of the said firearms in presence of accused person and then I seized the above narrated firearms and ammunition from his possession under proper seizure list and also labeled the same separately after obtaining signature of witnesses including one public witness. After seizure I arrested him at 19:35 hrs observing all the formalities regarding arrest as his offense comes under the purview of Indian Arms Act.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
