Respected Sir,

I, ASI Nehal Ch. Mandal S/O Lt. Balaram Mandal of Vill - Kendua P.S - Hirbandh Dist-Bankura, At present ASI of Kenda police station Dist- Purulia do hereby lodge this FIR as suomotu against arrested accd persons 1) Jaldaswar @ Banku Sabar S/O Lt. Sraban Sabar of Keshorgoriya P.S Kenda Dist- Purulia 2) Sibaram Mahato S/O Lt. Lalu Mahato of vill- Bansradih P.S Kenda Dist- Purulia along with the following seized items 01 (one) iron made dagger with handle measuring about 16", 01 (one) iron made 'Sobal' of which one end is curved measuring about 22", 01 (one) iron rod measuring about 40" and 02 (two) lathies, I beg to submit that today on 7.06.19 at 23.25 hrs. I received telephonic information from my reliable source that some criminals have assembled at Bagmara Jungle on Purulia-Manbazar High Road (SH-05) to commit any heinous crime in the nearby locality. Accordingly I communicated this information to my O/C Kenda P.S after diarizing vide Kenda P.S GDE.No. 213 dated 07.06.19 and as per his direction I proceeded towards the P.O. being accompanied by night mobile officers and force namely, ASI Manas Mukherjee to join us during the raid along with C/1572 Badal Mahapatra C/974 Dilip Kr. Ghosh. Vide Kenda P.S CC No 797 /19 At about 00:35 hrs. we reached near Sardardih more under Kenda P.S and leaving our Govt. vehicle bearing No. WB26C/7292 we started walking in groups very cautiously towards the area as pointed out by my source. At about 00.45 hrs. we reached in the North-West corner of the Bagmara Jungle under Kenda P.S and found that some men assembled inside the jungle and started walking with very slow steps. Their presence in that area at that dark hours of night appeared to be highly suspicious. Accordingly as per our earlier discussion and briefing we started to cordon the gathering from different angles. Having seen out approaching they started to flee away behind the jungle but for our hot chase we could manage to apprehend the above noted 02 (Two) accused persons. On search of their persons 01 (one) iron made dagger with handle measuring about 16", 01 (one) iron made 'Sobal' of which one end is curved measuring about 22", 01 (one) iron rod measuring about 40" and 02 (two) lathies, . All those articles were duly seized by me as recovered from their possessions respectively after preparing proper seizure list in presence of my accompanying police personnel as no public witnesses were found to be available then and in that locality at that dark hours of night. I also labeled the seized items properly duly signed by the accused persons and the witnesses. Copy of seizure list was served to the accused persons. On interrogation the above noted accused persons disclosed their identity as noted above and confessed their guilt and stated that they along with 1) Dantu Sabar of Pundru P.S Manbazar 2) Lilu Sabar of Karma Baridih P.S Baro 3) Lula Sabar S/O Tilo Sabar of Bagaldih P.S Barabazar and others assembled there for the purpose of committing dacoity to the nearby village house. Subsequently I arrested the above noted accused persons after disclosing them the grounds of their arrest and observing all legal formalities. I also arranged to inform their family members and relatives about their arrest by the police.

So, I pray before you that a specific case U/S 399/402 IPC may kindly be started against them and to arrange for its investigation.
