I, ASI Nehal Ch. Mandal S/O Lt. Balaram Mandal of Vill - Nekra P.S - Boro Dist- Purulia, At present ASI of Kenda police station Dist- Purulia do hereby lodge this FIR as suomotu against arrested accd persons 1) Ranjit Kumar Rajawar-(25 yrs) S/O- Lt. Apish Kumar Rajawar of village Gobindopur P.S - Kenda Dist- Purulia to the effect that On 20.06.19 in between 19.05 hrs to 19.35 hrs during special raid duty acting of a secret source information myself along with force vide Kenda CC. No-862 /19 Dtd- 20.06.19 conducted raid in the grocery shop of Ranjit Kumar Rajawar (25 yrs) S/O- Lt. Apish Kumar Rajawar of village Gobindopur P.S - Kenda Dist- Purulia at Gobindopur more and found that the above noted person is Storing and selling country spirit which were kept in grocery shop. On demand he failed to produce any valid document in respect of Storing and selling of liquor from the grocery Shop. As such he seized **(1)** 37 (Thirty seven) sealed bottles of Country Spirit styled as DIL SE each Bottle contains 600 ml **2)** 33(Thirty three) bottle contains 375 ml . Subsequently I arrested the above noted accused person after disclosing him the grounds of arrest and observing all legal formalities. I also arranged to inform his family member about his arrest by police.

Hence I pray kindly treated as FIR as per law and to arrange for its investigation.
