I SI Gopika Sundar Dutta, O/C, Kenda PS do here by lodge this FIR as Suo-moto against 1) Nilkamal Mahato S/O- Bhandu Mahato of Vill- Matha, PS- Kenda, Dist- Purulia 2) Sahid ansary S/O- Siraj Ansary of Vill- Belgora, PS- Kenda, Dist- Purulia 3) Bhaskar Mahato S/O- Lt. Pelaram Mahato of Vill- Belgora, PS- Kenda, Dist- Purulia and others to the effect that today at around 09.55 hrs received a Telephonic information that some persons had blocked Purulia-Manbazar Road (SH-05) near Matha Jore without any prior information or permission and a huge number of vehicles including public Buses and state Buses got obstructed. Accordingly myself along with SI. Bapan Mondal, ASI. Nehal Ch. Mandal, ASI. Manas Mukherjee and forces vide Kenda PS GDE No-774, Dtd- 26.06.19 rushed to the spot at 10.15 hrs and found that a large number of vehicles were obstructed in a queue and approx- 40/50 persons had blocked the Road by placing Date tree and Bamboo and wooden stick over the issue of demanding Concrete Road from Matha Jore' to Belgora village. The mob was unruly and some outsiders were also joined into the mob and they uttering filthy language aiming us thus making situation more panicy. Myself along with all officers and forces have tried to pursue the agitators to with draw the Road blocked and help Police to disperse the mob. It was also found that more then 50/60 different type of vehicle loaded with passengers and loaded goods and including drivers, patients, minor baby etc. from Kenda side and Manbazar side were detained there from 09.55 hrs. morning and subjected to enormous sufferings for a long time. The above accused persons continued to be with the unlawful assembly, causing unlawful restraint to the vehicles and passerby and thus generated danger and obstruction in public way. After prolong discussion with Jt.BDO Puncha and Police they withdrawn blockade at 11: 05 hrs.

Hence I do record Kenda PS Case No- 34/19 Dtd- 26.06.19 U/S - 143/145/149/150/151/186/506 IPC , Read with sec.18 of the west Bengal Highway Act. - 1964. as suomoto against approx 40/50 of Road blocked supporters and directed SI Ashoke Kumar Mahata to investigate the case.
