Sir,

In producing here with one accused person Ajodhya Mandi (29) S/O- Lt- Mukunda Mandi of village- Bisri PS- Manbazar, Dist- Purulia along with following seized articles viz-

- 1) 20 (Twenty Ltrs.) I.D. Liquor within a Jariken
- 2) 05 pieces plastic glass
- 3) Sale proceed of Rs- 65/-

I A.S.I. Indrajit Sarkar of Manbazar PS do here by lodged a complaint against accused namely Ajodhya Mandi (29) S/O- Lt- Mukunda Mandi of village- Bisri PS- Manbazar, Dist- Purulia to the effect that today (13.06.19) at 17:25 hrs. I received a telephonic information from a reliable source that one Ajodhya Mandi (29) S/O- Lt- Mukunda Mandi of village- Bisri PS- Manbazar, Dist- Purulia was stocked I.D. Liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 414 dtd- 13.06.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1211 Chunaram Hembram, C/1191 Subodh Hansda rushed to the spot for raid by Govt. vehicle. At about 18:05 hrs. myself along with force reached at Bisri village and held raid in the house of Ajodhya Mandi and found that said house keeper selling liquor at his own house and Seeing the police party some persons fled away and said Ajodhya Mandi tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling I.D. Liquor but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Ajodhya Mandi Bauri (29) S/O- Lt- Mukunda Mndi of village- Bisri PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
