Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Jiten Tudu (23) S/O- Lt. Rashik Tudu of Vill-Digha, PS-Neturia, District- Purulia along with seized I.D. Liquor approx 42 Liters in a plastic container which was seized under proper seizure list and approx 180 ml I.D. Liquor kept as sample.

I beg to submit that today (04.06.19) at 19:35 hrs while myself along with force were performing anticrime mobile duty near Sarbari more, received source information that one Jiten Tudu S/O- Lt. Rashik Tudu of Vill-Digha, PS-Neturia, District- Purulia has illegally stocked I.D. Liquor in his house at Digha village under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Digha village to work out the information. At 20.05 hrs after reaching at Digha village held raid in the house of Jiten Tudu S/O- Lt. Rashik Tudu of Vill-Digha, PS-Neturia, District- Purulia and found that the above noted person was keeping / selling I.D. liquor which were kept in his house, on demand Jiten Tudu failed to produce any valid documentary authority in respect of selling of I.D. liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also approx 42 Liters I.D. Liquor was seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Jiten Tudu (23) S/O- Lt. Rashik Tudu of Vill-Digha, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of I.D. liquor.

It may note here that during raid 1) C/1260 Santosh Saren, 2) C/1353 Atanu Ganguly and 3) C/1304 Dhananjay Mondal all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Jiten Tudu (23) S/O- Lt. Rashik Tudu of Vill-Digha, PS-Neturia, District- Purulia under proper section of law.
