Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **BHAJAN MUKHERJEE S/O- Late Atul Mukherjee of VILL-Bhalagora P.S.-Para, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 11.06.2019 at about 9:20AM, I Mr. Goutam Kr. Mandal, SM of DUBRA PARA C.C.C, along with Mr. Lakshman Mahato, Hg. Sr LM Dubra Para CCC and Mr. Bhaktipada Mahato, TSH of Dubra Para CCC inspected the premises of **BHAJAN MUKHERJEE S/O- Late Atul Mukherjee of VILL- Bhalagora), P.S.-Para, DistPurulia WBSEDCL**. During inspection and it was found that the said **BHAJAN MUKHERJEE** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension overhead line for running his 01no 1000watt electric heater and 01no 100watt bulb, approx load 1.110KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 9:35AM

As such **BHAJAN MUKHERJEE S/O- Late Atul Mukherjee of VILL-Bhalagora P.S.- Para, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
