

- 2. That the complainant and the accd presons are co-villagers.
- 2. That on the date of occurance on 2nd day of February, 2019 (18th Magh 1425 B.S.) at about 7'00 A.M. While the complainant and his son Mahesh Bouri are standing this ladd of mouza Amlatora, dag No.539 the accd persons forming and unlaful assembly criminally trespass the complainant land and abused them in filthy languages and threatened them with dire consequences. The complainant protested against such high hadded actions of the accd. persons to which acced persons namely (1) Gangadhar Bouri (2) Manik Bouri and (3) Mangal Bouri assaulted them severaly by fist and blows and assaulted the complainant by iron-road and he sustained bleeding injury on his face and he was taken to hospital for treatement for treatment, medical reprt is attached herewith.
- 3. This The complainant had been to the Anara out post unddr P.S. Para lodged written compliant beforethe police office, who assured him to enquired into the matter but no action has been taken as yet by the police
- 4. That again on 8th March 2019 at about 7.00 A.M. all the accd persons being variously armed with deadly weapones namely Tangi, sword etc criminally trespassed in to the house of the complainant with utterance "they would not spare the complainant and and would kill him to day on the less as the complainant was not preent in his house theaced. persons under the leadership of (1) Gangadhar Bouri (2) Mangal Bouri and (3) Manik Bouri excircled son of the complainant i.e. Maheh Bouri with the entitention to commit culpablehomicide and in order to achive the end accd. Dipu Bouri ained end below by Tangi on the head of Mahesh Bouri and as the latter some how could remove hilself he was saved from such murderousattack. The only intention of the accused persons was to commit homicide and the have eritition to commit culpablehomicide punishable u/s.308 I.P.C.
- That the witnesses and villagers came there and occurance been witnessed by them.



- 6. That the accd. persons before leaving the place of occurance agains threatened them to take theirlife in opportune moment leter on.
- 7. That the complainant had been to Para P.S. for lodging a complain before the police officer who assured him to enquire into the mattr and take action against them but no action has been taken as yet by the police officer. The complainant send written complain to the S.P.Purulia and O/C Para P.S. registered post for taking necessary action but the samehave als ifailed to take any positibe respons by registeringany specific case
- 8. That in order to persue the above steps substantial time has been that and hence this delay.
- 9. That the accd. persons have committed offences U/S.147/148/149/447/448/323/325/300/506 I.P.C.

It is therefore prayed that your honour will graciously be pleased to send this complain petition to O/C Para P.S. U/S. 156(3) Cr.P.C. to treat the same as F.I.R. and to a the needed investigation.
