On 21.03.18 Pratima Rakshit (Dey) go to her father's house without any information, and that time I was performing my duty. Her father Gopal Chandra Rakshit came to my house & told my parents that one marriage ceremony party was will be held on 23.03.2018 at Tulin and his daughter Pratima Rakshit (Dey) invited also. Further Gopal Chandra Rakshit told my parents that your son also known it. My parents said the matter will be cleared after arrival of my son, & also requested them till wait to come my son. But they left my house in order to Tulin with all gold ornaments from almirah.

When I was called over phone my father in-law that please send your daughter Pratima Rakshit to my house then they denied it, and my sister in law Smt Padmabati Rakshit threatened me & demanded my salary of every month to be handed over to Pratima Rakshit & also threatened to give up my parents though they are senior citizen. Further they demanded Rs.20 (Twenty) lacs for getting divorce from me, because Pratima Rakshit is not happy for this marriage. When I told my in-laws why they spoiled my marriage life they said "I am a police (Padmabati Rakshit) you are not realized the power of police you give money neither we filed a false 498A against your family". And then they continued threatened me. After this incident I had totally broken & feeling depression. And then one police officer attached Para police station Named N.Huda came to my house forcibly & illegally without any specific ground on 13.04.18 and instructed us to go to Para P.S on 16.04.18. When we attained Para police station Smt Padmabati Rakshit & Smt Alpana Rakshit used dirty language against me

Then a few month later they are registered a false FIR against me & my old parents in reference of Smt Padmabati Rakshit posted as a Jr. Constable attached at Jhalda police station & the police official are not proper investigated the complain due to Smt Padmabati Rakshit posted this police station as a Jr. Constable (WBP).

Therefore I am requesting you please investigate the proper matter & take necessary departmental disciplinary action against Smt Padmabati Rakshit, who continuously harassing & threatening me for this I can't do, my job normally.
