Sir,

In producing here with the arrested accused Ruban Mukherjee (27yrs) S/O-Nabagopal Mukherjee of Vill- Bishpuria, PS- Puncha, Dist- Purulia and one seized iron made improvised country made firearm having length 9.5 inch approx from butt to barrel, having firing pin and trigger along with one (01) round ammunition. Today i.e on 07.06.19 during my night mobile duty at 22:05 hrs received a credible source information that one Ruban Mukherjee is loitering suspiciously near Bishpuria village possessing a gun with him. I informed the matter to O/C Puncha PS and as per order I rushed towards Bishpuria village to work out the information. I SI Prasanta Sau along with force reached at Bishpuria village at 22:35 hrs and kept the vehicle at a distance from the spot and then proceeded towards the spot. We reached near Bishpuria village and found that one person is going towards Bishpuria village. We apprehended him and on asked he disclosed his identity as Ruban Mukherjee (27 yrs) S/O- nabagopal Mukherjee of Village -Bishpuria, PS- Puncha, Dist- Purulia. On search found that he possessed one iron made improvised country made firearm having length 9.5 inch approx from butt to barrel, having firing pin and trigger along with one (01) round ammunition is fitted. On asked he could not able to produce any licence or valid document in respect of possessing or carrying of that improvised fire arms. Finding no other alternative I arrested him after informing him the ground of arrest and after observing all legal formalities and also seized the iron made improvised country made firearm with one (01) round ammunition from the exclusive possession of the arrested accused person Ruban Mukherjee under proper seizure list in presence of witnesses duly signed by them.

Under the above circumstances I pray before you for starting a case under proper section of law against accused Ruban Mukherjee (27yrs)S/O- Nabagopal Mukherjee of Vill- Bishpuria, PS- Puncha, Dist- Purulia for possessing and carrying of improvised country made fire arms and arrange for its investigation.
