Entered the premises of Sri Ramkrishna Banerjee, Vill & P.O - Pancha
P.S. Pancha, Dist - Purulia, having Consumer No. 242012992 Meter No. B3894348
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I) (a) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) A.C Machine - 1500 Watt = 01 (one)
- 2) Colour T.V. 100 Watt - 01 (one) nos
- 3) Fan - 80 watt each - 10 (ten) nos
- 4) Tube light - 40 watt each - 10 (ten) nos
- 5) L.B.D. Lamp - 10 watt each - 10 (ten) nos
- 6) Refrigerator - 120 watt - 01 (one) nos
- 7) Pump - 11.19 Watt - 01 (one) nos

Out of which I seized the following.

- (i) Single Phase Meter NO B3894348 and bypassing cable.
- (ii) Main switch - 01 (one) nos. 32 Amp. 230 volt.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 12:55 on 13.06.2019. The accused person has committed an offence
U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be
taken as per rule.
