Sub: Prayer for lodging a specific case

Sir,

With due respect and humble submission I, ASI Madhu Mangal Bauri of Tamna O.P beg to state that on 03/04.06.19 night in course of my night mobile duty while at about 02.15 hrs I along with CVs namely Sanjit Chatterjee and Sukhendu Chowdhury reached near Chakaltore more at that time one driver of a vehicle which was going towards Barabazar informed me that an accident took place near Chandradih more. After getting this information I along with CVs rushed by our mobile van to Chandradih more to look into the matter. When I reached at Chandradih more I found that a vehicle bearing No- WB57C/7555 was stood there and the driver namely Abir Sk s/o Saiful Sk of Vill- Sakupara, P.O- Arjunpur, P.S- Farakka, Dist- Murshidabad (W.B) of the said vehicle received injury on his person. I informed the matter to my I/C of Tamna O.P. I asked the driver and Khalasi namely Ajarul Sk s/o Enamul Sk of Vill- Sakupara, P.O- Arjunpur, P.S- Farakka, Dist- Murshidabad (W.B) of the said vehicle regarding the incident. They told that while they were coming from Purulia side to Tata at that time near Chandradih more suddenly the left side rear tyre of his vehicle was punctured and the driver was compelled to stop the vehicle at near Chandradih more. After that 03/04 unknown persons came there and assaulted the driver and Khalasi also with lathi, rod etc and snatched cash Rs-4000/- (Four thousand only), two mobile sets (Zen which bears mobile No- 9144587382 and one Jio mobile which bears mobile No- 6294448524) and driving license of the driver and then fled away. As a result, said driver received injury on his person. Then I searched the adjacent areas to arrest the accd. persons but to no good. Then after placing two CVs near the vehicle I along with my accompanied CVs went to Chakaltore Hospital for medical treatment of the said injured driver. After medical treatment I along with CVS and driver, Khalasi returned to the spot. In the mean time I/C Tamna O.P already reached at the spot and searched jointly here and there at the adjacent places of the spot but the result was no fruitful. The victim driver was asked to submit complaint or to put signature on recorded statement of police for starting specific case in this respect but he denied and stated that after consultation with owner of vehicle he will act accordingly. The vehicle was loaded with fruits and perishable material hence the driver with vehicle left to unload the vehicle immediately.

Therefore, I pray before you that necessary steps may kindly be taken to lodge a specific case against the accd. persons.
