

With due respect I the undersigned would like to inform you that, today Sir, that is on 21.06.2019 at about 10.00 AM morning, while I came out from my house for fetching water from nearby the municipal tap, I found that a piece of cloth blocked the drain from my kitchen and I opened the said cloth from my drain. At that time Manju Bauri wife of Rajen Bauri and Sushmita Bauri Daughter of Rajen Bauri both are residents of Sinderpatti, within P.S. Purulia Town, District Purulia, abused me with filthy languages, while I protested, both of accused persons snatched me over different parts of my body with their nails and also assault me with fist and blows and also torn my wearing cloth. I shouted and my son namely Biblab Rao aged about 12 years, son of Swapan Rao came there to save me from the hands of the accused persons but Sushmita Bauri leaving me assault my son over his head by a big stone, with an intention to kill him; anyhow I managed to escape there from with my said son and I rushed to the Purulia Deben Mahato Sadar Hospital for our treatment. I made phone call to my husband and he came to the hospital. I narrate the incident to my husband. The attending doctor admits my son as indoor patient, as he was seriously injured.

Be it mentioned here that the accused persons often block our said drain and create nuisance.

As my husband and I both are busy for treatment of my said son, so I could not file this complaint immediate after the incident. Now my humble request to you please take necessary legal action against the accused persons named above.
