P.S. Purulia (T) Dist- Purulia, having Consumer No. 242023811 Meter No. L1529A2

and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSIEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 08 nos.
- 2) CFL - 05 nos.
- 3) Water Pump - 08 nos.
- 4) TV - 01 nos.

Out of which I seized the following

- 1) PVC 2 Core Service Connection Cable along with by-passing arrangement - 02 ft (attached).

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 14:24 hrs. on 10/06/19. The accused person has committed an offence
U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
